
NOW-IT IS AGREED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS

The lessor agrees to demise to the lessee and the lessee agrees to take on lease the said piece and parcel of lands and buildings standing thereon, more particularly decribed in the schedule hereunder written for a period of Thirty years commencing from 14-03-2014 to 13-09-2042 which is the date of agreement entered in to between the parties to lease out the schedule lands to the lessee for Twentynine years Six Months at the yearly Rent of Rs. Thousand per year, per acre accordingly for 00-18gunts and 01-22guntas the rent comes to Rs.5,000-00 (Rupees Five Thousand only) Deposit to the buildings do not carry any rent and the rent is subject to revision on the request that may be made be the lessor to lessee from time to time with mutual understanding between the lessor and lessee which shall be carried out by resolution that may be passed by the lessee.

The first three years from the date of possession of the schedule land to the lessee is considered as construction period, during this peiod the lessor shall not charge any rent on the schedule lands and the lessee shall complete construction works within three years from date of possession of the schedule land given to the lessee and the lessee shall start paying the rent as agreed, from the foruth year without fail and the rent is payble once in every year during the month of April.

The lessor shall make out a marketable title to the schedule land free from all encumbrance and claims or reasonable doubts.

The deed lease will contain usual covenants to be given by the lessee and lessor and other usual terms and conditions provided that there will be no restrictions on the lessee's right to assign the lease and the deed of lease will also contain a conditions that on the determination of the lease by efflux of time or otherwise, the lessee will surrender the land to the lessor along with building and buildings standing thereon without any compensation, the lessee shall not sub lease the schedule property any without the permission of the lessor.

The lessor already given the complete vacant possession of the schedule lands to the lessee on $\frac{14-3-14}{200}$ and $\frac{13-3-13}{200}$ which is the date of agreement entered in to between the parties.

All the taxes, the outgoings water charges, electrical charges, and any other maintenance charges in respect of the said land after commencement of the lease sahll be paid by the lessee.4

The lessee shall be at liberty to construct buildings or buildings thereon with all requisite and proper sewers, drains and other conveniences and the constructions shall be according to the plan sanctioned by the competent authority.

If any permissions and sanctions that are required to be obtained from the competent authority for the completion of the lease deed, shall proveded by the lessor.

If the lessor fails to carry out the terms and conditions herein provided, the lessee will have option to cancel this agreement by fifteen days prior notice to the lessor. if the lessee fails to carry out the terms and conditions herein provided, the lessor will have the option to cancel this agreement by fifteen day's prior notice to the lessee to that effect.

Lessee shall handover the possession of the schedule property to the lessor on cancellation of the lease of the lease deed or on termination of the lease after completion of thirty years along with buildings or structures and any other developments that are carried out by the lessee during the period of lease.
